Please refer to this office circular of even no. dated **14.03.2024**, regarding the enhancement of the ceiling on the cost of frames for spectacles from Rs. 500/- to Rs. 1200/- for Insured Persons (IPs) and their dependents.

The Competent Authority has accorded approval for **Extension of Benefit of the enhanced ceiling of Rs. 1200/- for the cost of spectacle frames to the ESIC Employees, Pensioners, and their dependents** who are availing medical facilities from ESIC Hospitals. The replacement of spectacles for these beneficiaries will be provided **once in five years**, as per the prevailing practice. Suitable records, preferably online, to be kept available mandatorily by the relevant Department & Hospitals/Offices for Auditing.

**विषय: बीमाकृत व्यक्तियों को चश्मे की आपूर्ति -फ्रेम की लागत पर अधिकतम सीमा का निर्धारण।**

महोदय/ महोदया,


जैसा कि आपको ज्ञात है कि बीमाकृत व्यक्तियों को उनकी कार्य क्षमता में सहायता प्रदान करने के लिए विशेषज्ञ चिकित्सकों द्वारा निर्धारित कुछ उपकरण उपलब्ध कराए जा रहे हैं। चश्मा एक ऐसा उपकरण है जो विशेषज्ञों की सलाह पर बीमाकृत व्यक्तियों को उपलब्ध कराया जा रहा है।

वर्तमान में, चश्मे- फ्रेम की लागत के प्रावधान के लिए बीमाकृत व्यक्तियों को 500/- रुपये की दर पर प्रतिपूर्ति किए जाने की अधिकतम सीमा निर्धारित है।

एक अवधि से अधिक में चश्मे के फ्रेम की दरों में वृद्धि को ध्यान में रखते हुए, सक्षम प्राधिकारी ने बीमाकृत व्यक्तियों और उनके आश्रितजनों को प्रदान/ प्रतिपूर्ति की जाने वाली चश्मे की लागत की अधिकतम सीमा को 500/- रुपये से बढ़ाकर 1200/- रुपये करने की स्वीकृति प्रदान की है। वर्तमान पद्धति के अनुसार चश्मे को पांच वर्ष में एक बार बदलने की व्यवस्था होगी।

इसे सक्षम प्राधिकारी के अनुमोदन से जारी किया जाता है।

Sir/Madam


As you are aware that certain appliances prescribed by specialist doctors are being provided to the Insured Persons for their use to aid to their working capacity. Spectacles is one of the appliances which is being provided to the Insured Persons on the advice of the specialists.

At present, there is a ceiling prescribed for provision of spectacles-cost of frames to be reimbursed to the IPs at the rate of Rs. 500/-.

Now, keeping in view of the increase in the rates of frames of spectacles over the period, the Competent Authority has accorded approval for enhancement of the ceiling on the cost of the Spectacles to be provided/reimbursed to the insured persons and their dependents from Rs. 500/- to Rs. 1200/-. The replacement of spectacles will be provided once in five years as per present practice.
